

TR-T03 Course Entry Requirements Policy

Purpose

This policy outlines the criteria and procedures for determining the entry requirements for prospective students applying to nationally recognised training courses at Tr4inRight. It ensures that students possess the appropriate academic background, English language proficiency, and core learning competencies to undertake and complete vocational education and training successfully.

It supports transparent admissions practices, equitable access, and compliance with the Outcome Standards for RTOs 2025, ESOS Act 2000, and National Code 2018, ensuring that both domestic and international students are well-informed and assessed fairly.

Scope

This policy applies to all applicants (onshore and offshore) seeking admission into accredited training products on Tr4inRight's scope of registration, including CRICOS courses delivered to international students.

Definitions

- **LLN Test:** Language, Literacy and Numeracy test conducted internally to assess a student's ability to engage with the course content.
- **Oxford Placement Test (OPT):** An online English proficiency test accepted and used by Tr4inRight to verify entry-level English skills of a prospective learner in the absence of any other form of language proficiency evidence.
- **Conditional Offer:** A letter of offer issued when the applicant meets most but not all entry requirements, subject to further conditions.
- **PRISMS:** Provider Registration and International Student Management System used for managing COEs and visa compliance.

Policy Statements

1. Minimum Age

All students must be at least 18 years of age at the commencement of the course.

2. English Language Proficiency (VET Courses only)

All applicants must demonstrate a minimum English proficiency equivalent to **IELTS 5.5**. The equivalencies include but are not limited to (refer to Appendix 1):

- TOEFL iBT (46–59)
- Cambridge English Scale (162)
- PTE Academic (42)
- OET (C grade)
- ELICOS (Upper Intermediate Certificate from an Australian ELICOS provider)
- Completion of Certificate IV or above in Australia
- Successful completion of Year 12 in Australia
- Successful completion of the Australian Foundation Year program
- Successful completion of minimum one year of study in Australia in VET in AQF Level 4 or higher
- B2 result in Oxford Placement Test (administered by TR4INRIGHT)
- Five years of full-time study in English in eligible English-speaking countries

Note: Tr4inRight reserves the right to review the documentation provided by each student and assess whether they meet the course entry requirements on a case-by-case basis. This is to ensure fair judgement of the individual circumstances that may be presented to the admissions department.

Exemptions apply if the applicant:

- Holds a passport from UK, USA, Canada, NZ, Ireland
- Has completed Year 12, Professional Year, or Senior Secondary Certificate of Education in Australia in English within the last 2 years
- An applicant who has successfully completed and achieved a Certificate III or higher in vocational Education in Australia within the last 2 years
- An applicant who has successfully completed a minimum of 5 years of study in English undertaken in one or more of the following countries: Australia, Canada, New Zealand, South Africa, the Republic of Ireland, the United Kingdom, or the United States of America.

If no evidence is provided, applicants are required to undertake the Oxford Placement Test.

3. Academic Entry Requirements (VET Courses only)

All students must provide evidence of satisfactory academic achievement equivalent to **Australian Year 12**. International applicants must demonstrate this via:

- National senior secondary school certificate
- Equivalent as listed in **Appendix**

- Completion of AQF Certificate III/IV in Australia
- Completion of International Baccalaureate (min. 24 points)

Students who do not meet the academic equivalency may be accepted through completion of the LLN Test at a level indicating no support needs.

If a document, a completion of course provided that is not listed in this policy, Tr4inRight reserves the right to assess the qualification and determine its equivalency to Australian Year 12 or request additional evidence such as an LLN test to ensure student meets course entry requirements.

4. LLN Testing (VET Courses only)

TR4INRIGHT reviews LLN and digital literacy of students prior to enrolment and also prior to commencement of studies.


Prior to enrolment, LLN and digital literacy is reviewed through review of enrolment documents, responses to application form and Pre Training Review forms, and other evidence that may be presented to admissions department.

All students are then required to undertake the LLN Test administered by TR4INRIGHT during their orientation session, unless exempt through Australian qualifications or prior LLN test results. Results are used to identify if support strategies are needed.

5. Internal English Testing (VET Courses only)

Where no external English evidence is available, TR4INRIGHT issues an English Proficiency test to students. This may be an internally developed test or the **Oxford Placement Test**. A result at B2 level on the CEFR scale is required. A report is generated after each attempt of the OPT. Reports are stored in the student file. Below is a sample OPT portal test report.

Schools can co-brand report cards with their own logo.



Overall Result includes:

- score
- CEFR level
- time taken for test

Section Result includes:

- score
- CEFR level
- time taken for test (for each section of the test)

Teachers can add their own message for their students.

Information about what a learner that achieves a particular CEFR level can typically do. These 'Communicative competencies' are adapted from the CEFR companion volume, and are provided for each section of the test.

A score guide shows the CEFR levels, the corresponding score bands, and how the levels can be divided into plus levels. You can use this scale to see where in a CEFR band a learner's score sits.

6. English Placement Test (ELICOS Only)

Where no external English evidence is available in the case of enrolments for ELICOS courses (i.e. General English and English for Academic Purposes), students must attend an English Placement test prior to enrolment to provide admissions team information about adequate study duration. Generally, an OPT will be used at this stage.

All ELICOS students will sit an additional English Placement Test at the time of orientation to further establish and validate their level of proficiency and determine the right level to which they will join.

7. Availability of Information

Accurate and detailed course entry requirements are provided to students in Tr4inRight website among other resources.

Procedures

1. Application Submission

- Applicants submit a completed Application Form with all required documentation:
 - Academic transcripts (certified for offshore applicants)
 - English language evidence
 - Evidence of meeting course prerequisites (If applicable)
 - Colour scanned copy of their current passport with all details and photo visible
 - Visa and OSHC (where applicable)
 - Statement of Purpose (offshore applicants)
 - Statement of Attainment/Certificate along with a statement of result for all CT and RPL requests
 - Unique Student Identifier (USI)
 - Pre-training review form
 - Any current or previous CoE, and evidence of academic achievements –
OPTIONAL
 -

Documents in a language other than English must be translated to English by certified translators.

All documents for offshore applications must be certified by a government agency.

If the applicant is claiming Credit Transfer – the Statement of Attainment or Qualification certificate must be verified with the issuing authority (the provider, or ASQA if provider does not hold current registration) by the admissions officer. The authentication must occur in writing and evidence will be saved in the student file.

The student will be required to apply for Unique Student Identifier (USI) if he/she does not have one.

2. Document Review

- Admissions staff review documents for authenticity, accuracy, and compliance.
- Applicants with missing English evidence are issued the English proficiency test.

3. Offer Issuance

- A **Letter of Offer** is issued (conditional or full), outlining tuition fees, duration, and conditions for successful applicants.
- Applicants are required to sign and return the Letter of Offer (to be addressed as “Acceptance” post being signed) and make the initial tuition fee deposit as indicated in the Letter of Offer.

4. COE Issuance

- Upon acceptance, a Confirmation of Enrolment (CoE) is issued in PRISMS for all student visa holders, and a Verification of Enrolment (VoE) is issued for all non-student visa holders and domestic enrolments.
- If RPL or CT reduces course duration, the CoE/VoE is adjusted, and the change is reported to PRISMS (If applicable).
- If Standard 7 (student transfer) applies, evidence of release must be assessed before CoE issuance.
- If all required documents and evidence is not provided prior to CoE/ VoE being issued, then only a conditional CoE / VoE will be issued. In such case all requirement documents must be provided prior to course commencement.
- For all CoE and VoE with CT applied, the condition related to requirement for TR4INRIGHT to authenticate all CT related evidence applies.

5. Pre-Enrolment Orientation

- All students undertake orientation where final LLN tests may be administered, and support needs identified.
- Students will complete enrolment forms, receive timetables, and training on vital and required information in relation to they journey at TR4INRIGHT, their course and study requirements, and their obligations as a student.
- If a student is not able to attend the orientation session, further arrangements will be made by the admission team, such as an online orientation session where documents can be submitted through email (for continuing students), or an individually arranged orientation session. Student will not be able to commence study until the orientation process and documentation is complete.

Responsibilities

CEO	Ensures all marketing and sales team and admissions department are fully trained and aware of course entry requirements and prerequisites, and all education agents receive accurate training and information on the matter.
Marketing Team	Ensure all prospective students and all third party education agents are aware of TR4INRIGHT's course entry requirements and provide complete, and accurate information at the time of enrolment.
Admissions Officers	Verify application documents, issue tests, prepare Letters of Offer
Compliance Manager	Determining and providing course entry requirements and prerequisites information to the broader team, approve final admission decision where conditions apply, audit of policy compliance, PRISMS, LLN and orientation process


Review and Continuous Improvement


APPENDIX – 1: IELTS 5.5 Equivalency Guidelines

APPENDIX – 2: Minimum Schooling Equivalency Guidelines

Australian Year 12 Senior Secondary Certificate of Education – satisfactory completion

Australian Year 11 + successful completion of a vocational course of AQF level Cert III or IV or above.

Australian Year 11 + successful completion of the TR4INRIGHT LLN test, that determines “no additional support required”

International Equivalent education to Australian year 12, as outlined in Appendix 3 of this policy.

Cambridge International: GCE A-Level* (2 passes with an aggregate score of 3)

International Baccalaureate Certificate (IB): International Baccalaureate Diploma with a minimum score of 22

New Zealand National Certificate of Educational Achievement (NCEA) at Level 3.
